## SCDP Delegates

SCDP Delegates are elected to serve at the SC Democratic Party Convention on May 31st and will hear from and vote on state party leadership candidates, resolutions that were approved at March county party conventions, and be inspired to action by motivating speakers and plans for our path forward.

Richland County will elect up to 142 Delegates and 28 Alternate Delegates, divided equally by gender, for a one-year term.

## Precinct Executive Committee Members

The Richland County Democratic Party is governed by one Executive Committee Member (ECM) and one Alternate ECM from each of the county's 149 precincts.

ECMs provide important input and perspective in this large and varied county. The Executive Committee meets 4 times a year, serving for a 2-year term. Ideas and organizing actions result from our coming together, and sharing of ideas & actions.

## RCDP County Party Officers

Leaders in the county party are focused on achieving the RCDP mission of electing Democrats and encouraging participation in the political process by people from of all backgrounds. Diversity is proudly and intentionally built into party leadership roles, including:

- **Chair**
- **1st Vice Chair** (different gender than the Chair)
- **2nd Vice Chair** (different race than the Chair)
- **3rd Vice Chair** (under 36 years of age)

**Executive Committee Representatives** serve as the governing body of the SC Democratic Party. Each county is allotted four representatives who attend monthly meetings and report back to their county Executive Committee and leaders with relevant information:

- Executive Committeeman
- Alternate Executive Committeeman
- Executive Committeewoman
- Alternate Executive Committeewoman
